FORENSIC INTERVIEWS

A forensic interview is conducted at the Children's Advocacy Center when there has been a report to law enforcement or Children's Protective Services that a child may have been a victim of sexual abuse.

Forensic interviews are intended to elicit detailed information about a possible event(s) a child may have experienced. Our interview process is developmentally sensitive, unbiased and truth-seeking to support fair and accurate decision-making in the criminal justice and child welfare systems.

THERAPY

Children between the ages of 5 and 18 who have experienced sexual abuse may be referred to the Center for therapy. We offer several types of therapy, body safety, individual workshops, age-specific therapy groups, and parent support groups.

All of our therapists have specialized trauma training and are experienced in utilizing evidence-based treatment approaches with children and adolescents. The goal of therapy is to provide a safe space for families to engage in their healing journeys through the guidance of client-centered, individualized treatment goals.

The CAC clinical team also has a caregiver therapist on staff who is available to provide support for parents/caregivers who may need to process their emotions with someone that understands the complexity and trauma of child sexual abuse.

PROBLEMATIC SEXUALIZED BEHAVIORS (PSB)

Offered for children age 9 and under who have not disclosed sexual abuse but have exhibited problematic sexual behaviors. A trained specialist will meet with both the parent/caregiver and the child individually to gather information around the concerns, provide education around body safety and offer potential treatment recommendations.

FAMILY ADVOCACY

How well a child copes following the disclosure of sexual abuse has a lot to do with the support of the family. Our Family Advocate plays a key role in helping both child victims and their families in the aftermath of a crisis and/or trauma. The advocate can provide access to needed information, specialized services and support throughout the healing and justice processes.

CAREGIVER SUPPORT

Caregiver support services were created to support parents/caregivers as they work through their child's trauma, as well as continue to navigate daily struggles. The parents/caregivers meet one-on-one with the client support specialist on an "as needed" basis to identify needs and work to overcome any barriers to meet those needs. The client support specialist can assist the parents/caregivers with navigating local resources such as food pantries and the bus system, fill out paperwork to obtain services, and locate counseling services.

KIDS HAVE RIGHTS

Kids Have Rights is a prevention program of the Children's Advocacy Center. Our program educates and empowers students, school staff, parents and caregivers to recognize, prevent, and stop child sexual abuse. The Kids Have Rights staff is composed of certified teachers with over 40 years of classroom experience between them.

PROFESSIONAL & COMMUNITY EDUCATION

National statistics tell us that approximately 1 in 10 children will be sexually abused before their 18th birthday, and as many as 90% of those children know their offender; it is someone the child knows, loves, and trusts. In Kent County, 99% of children that enter our doors know their offender.
