



FROM THE PRESIDENT/CEO

Increasing Accessibility

As I approach my four-year anniversary as director of this organization, there is hardly a day that goes by – even in the most challenging moments of my work– that I am not still stunned that I get to be part of this organization. The opportunity to support our committed and incredibly hard-working staff, partners and volunteers is a true honor. Regularly, I am witness to their dedication and seemingly tireless efforts.

It also holds true that I cannot see those things and not be heart-achingly aware of the pain and trauma endured by our clients and families. However, through the efforts of our team, I am also witness to the hope and sanctuary we are able to provide to

families who come to us for justice and healing. This past year alone, 874 new children and their families came through our doors for the first time. It is a number that is staggering and difficult for me to comprehend, and particularly because it does not even include those clients who were already engaged with us for counseling, court support and case management services.

Early in my tenure here, I remember learning that we had served close to 1,000 kids the year before. That took my breath away. It is roughly the population of an elementary school in a suburban community. But then I considered the statistic that 1 in 10 children will experience child sexual abuse before their 18th birthday and I did the math. One tenth of the population of kids under 18 in Kent County (at the time) equated to well over 15,600 children. I realized with incredible dismay that while we were doing life-changing work for those 1,000 kids who were coming here, to reach 15,600 more we had so much more to do.

Even during the more restrictive periods of the pandemic, our staff and board began earnestly exploring ways that we might begin to reach them. We estimate that there are likely a significant number of barriers that exist for children across Kent County. Over the next few years, we will:

Lean In.

- Continue to foster partnerships with neighborhood associations, faith-based institutions, schools, and community health centers to collaborate on ways to best support families
- Seek to grow partnerships with Kent County businesses and institutions through a call to action to come alongside us in radically reducing child sexual abuse by leveraging their unique resources, skills, and connections

Listen.

 Work collaboratively with families and communities in finding ways to overcome barriers to service and support by first listening to understand what challenges they face in seeking services

Lead

- With the support of seed funding provided by the W.K. Kellogg Foundation, convene a team of stakeholders
 to create a comprehensive plan to understand, address and reduce race-based inequities that heavily
 contribute to the trauma experienced by victims/families of color
- Expand the accessibility and availability of our services to areas of high need, through partnerships such as
 the satellite location we launched in June 2022 at Cherry Health Heart of the City Health Center or to rural
 communities in Northern Kent County
- Above all: Strive to build families' trust in us and the systems we work in by welcoming and encouraging their partnership in decision making regarding their child's and family's healing journey

It bears repeating, child sexual abuse is a community-wide problem. While we are committed to leading the charge, we cannot move the needle alone. It is imperative that we are joined in this effort. As we turn the corner toward 2023, please consider joining us in our important work. We need participation from individuals, businesses, educational institutions, community-facing organizations, social service agencies, churches, youth serving organizations and the media. New Accessibility Initiatives

At the CAC we serve on average 1,000 children annually. While this number may seem alarming, it is estimated that there are an additional 15,600 children whose abuse goes unreported each year in Kent County alone. In an effort to reach the children we are missing, we have undertaken two new initiatives to reduce barriers in accessing our services.

We recently started providing mental health services to our clients at a new satellite office, located at Cherry Health's Heart of the City Health Center (pictured right). By partnering with Cherry Health, we're able to provide another option for our clients to receive important therapy services at a location that may be more convenient and in which they already have a trusted medical home.

The CAC was also awarded a grant from the W.K. Kellogg Foundation to reduce race-based inequities for children of color. In collaboration with community partners, we will utilize a victim-centered approach to create a robust plan




to reduce race-based inequities for Kent County children of color impacted by child sexual abuse. With this initiative, we can create a more trauma-informed system to serve all child survivors. Through listening and inquiry conducted in partnership with community members, we will ensure services at our CAC are culturally attuned and child and whole family centered for all children in our county.

FY22 Finances



*State and Federal Grants include funds from Victims of Crime Act (VOCA), CAC Fund administered by Division of Victim Services, and National Children's Alliance funds provided by the US Department of Justice.

These statements do not reflect approximately 3,900 hours donated by our volunteers and interns during the fiscal year. The value of their hours is estimated at \$106,764 for the fiscal year.







Community Outreach & Prevention

Throughout this year, the CAC has collaborated with one of our ONEinTEN partners, Kent Intermediate School District, to help inform and empower the mandated reporters of our community.

Together we streamed the documentary REWIND, and were joined by its director Sasha Joseph Neulinger for a Q&A and panel. Discussions centered around the long-term impacts of trauma, how to recognize and report suspected abuse, and how to serve as an advocate for children.

Other highlights from the past year include:

- Provided 39 trainings covering how to recognize and report child sexual abuse, empowering 957 community members to serve as advocates for children.
- Increased community education on adverse childhood experiences, vicarious trauma, and compassion fatigue.
- Engaged 16 individual volunteers and three groups, providing a total of 476 volunteer hours.
